SIMPLIFIED STATE AND LOCAL BUSINESS TAX REGIMES**

We refer to the above subject and wish to state as follows;

- (a) That the Presumptive Tax Regulations is a national document, which is usually circulated by Joint Tax Board (JTB). This Regulation has recently been reviewed and is currently waiting for the signature of the Honourable Minister for Finance. As soon as this review is completed and we receive a copy from the JTB, we will make it available to you.
- (b) That the State Government and the Local Government Councils are already operating consolidated Demand Notice whereby the Presumptive Tax, Local Government Shop Levy and the Business Premises Fees a taxpayer is expected to pay are subsumed in one demand notice serves on him/her by the EIRS (attached are sample Demand Notices as proof of this operation).


